A non-corrosive floor finish stripper that rapidly penetrates and solubilizes floor finish. Powerful solvents, combined with penetrating amines, dissolve the finish on contact, reducing the waiting periods for removal of the finish. This product completely evaporates from the surface and requires little, if any, scrubbing. Its non-corrosive formula has a lower pH than traditional strippers, and does not require a neutralizer after stripping.

DIRECTIONS

Sweep or dust mop the floor to remove any debris. Dilute stripper 1:4 – 1:10 with cold water. Apply the stripping solution liberally, using a mop or automatic scrubber. Do not allow the stripper solution to dry. Be sure to completely cover floor to baseboards. Scrub with a rotary floor machine equipped with stripping pads. Pick up the solution and old finish with a wet vacuum or clean mop. Rinse thoroughly with clean cold water.

NOTICE: Wet floor may become extremely slippery. Be sure to keep pedestrian traffic away from floor until thoroughly dry.

STORAGE

Store in a well-ventilated place, and in a closed container away from heat, sparks or open flames. Keep container tightly closed, and avoid contact with skin and eyes. Wash hands before eating, drinking, smoking or using toilet facilities. Close container after use.

SPILL/LEAK

Avoid runoff into storm sewers and ditches which lead to waterways.
